W&W service facilities consist of an aerobic digesting package sewer plant with a tertiary lagoon along with the lines, manholes, and lifts necessary to make it operate properly. The number of customers is 63 with 62 being single family residences and 110 apartments with 28 of these being 1 bedroom apartments.
