
Dear Mr. Derouen:

Kindly be advised that I am corporate counsel to American Broadband, Inc. I am in receipt of the Kentucky Public Service Commission's Order dated October 12, 2011 in the above-referenced matter.

We acknowledge that our 2010 Long Distance Carrier gross operation report was not timely filed in accordance with the Order. Unfortunately, that was due to a misunderstanding on our part. We inadvertently contacted the Department of Revenue to confirm any liability, and erroneously believed this to be the extent of our filing obligations. We have put procedures in place to ensure our future annual reports are timely filed.

We understand that in October 2011, the Commission offered to accept a payment of \$250 as a fine. Although that deadline has passed, we have spoken with members of the Commission's staff, who indicated that we can make a proposal to resolve the penalty amount. We are enclosing a check in the amount of \$500 in full satisfaction of the fine. Kindly advise if this is acceptable.
