A public information session and public hearing was held at the Kentucky Public Service Commission's office in Frankfort, Kentucky on June 18, 2013. It was linked by video-conferencing technology to Paducah, McCracken County, Kentucky. A Power Point presentation was shown which explained the procedure and protocol for the information session and the public hearing. The presentation included an overview of the legal basis, criteria, and review process for the Commission's consideration of applications for proposed rate increases. The presentation included a general overview of the instant application and explained which aspects of this case are within the Commission's jurisdiction.

At the conclusion of the information session, Vice Chairman James W. Gardner initiated the public hearing portion of the meeting, providing a brief overview of the case at bar, the parties involved, and setting forth the procedure and protocol for the taking of comments. Vice Chairman Gardner then invited the public to make comments to the Commission regarding Big Rivers Electric Corporation's ("Big Rivers") application for an adjustment in rates to increase adjusted annual revenue.
