AMENDMENT TO THE LOCAL WHOLESALE COMPLETE COMMERCIAL AGREEMENT BETWEEN

BELLSOUTH TELECOMMUNICATIONS, INC. D/B/A AT&T FLORIDA, AT&T GEORGIA AND AT&T NORTH CAROLINA; ILLINOIS BELL TELEPHONE COMPANY D/B/A AT&T ILLINOIS; MICHIGAN BELL TELEPHONE COMPANY D/B/A AT&T MICHIGAN; THE OHIO BELL TELEPHONE COMPANY D/B/A AT&T OHIO; SOUTHWESTERN BELL TELEPHONE COMPANY D/B/A AT&T TEXAS; PACIFIC BELL TELEPHONE COMPAY D/B/A AT&T CALIFORNIA; THE SOUTHERN NEW ENGLAND TELEPHONE COMPANY D/B/A AT&T CONNECTICUT

AND PAETEC COMMUNICATIONS, INC.

This Amendment (the "Amendment") amends the Local Wholesale Complete ("LWC") Commercial Agreement – LWC by and between <u>AT&T-22STATE</u>¹ and PaeTec Communications, Inc. ("PAETEC") effective as of August 15, 2009 (the "Agreement"). <u>AT&T-22STATE</u> and PAETEC are hereinafter referred to collectively as the "Parties" and individually as a "Party".

WHEREAS, the Parties desire to extend the term of the Agreement and make certain other changes as set forth below.

NOW, **THEREFORE**, in consideration of the promises and mutual agreements set forth herein, the Parties agree to amend the Agreement as follows:

- 1. Section 8.2.1.1 of the General Terms & Conditions to the LWC Agreement is hereby added as follows:
 - 8.2.1.1 The Parties agree to delay the implementation of the new rate structure in the Local Wholesale Complete Extension Amendment effective January 1, 2012, until May 1, 2012, as a result of the merger of Windstream Corporation and PAETEC Holding Corp., for the express purposes of an orderly completion of activities as a result of that merger that occurred during the negotiation period of the 2014 LWC extension. The implementation of the new rate structure shall include retroactive true-up of the rates in the Local Wholesale Complete Extension Amendment back to January 1, 2012 including proration of such rates on any LWC lines that were added, changed, or disconnected during this period between January 1, 2012 and April 30, 2012.
- 2. Sections 8.2.3 and 8.2.3.1 of the General Terms & Conditions to the Agreement are hereby added as follows:
 - 8.2.3 The Parties shall enter into a successor agreement ("Successor Agreement"), prior to April 30, 2012, which shall require retroactive true-up of the Successor Agreement rates

back to January 1, 2012 including proration of such rates on any LWC lines that were added, changed, or disconnected during this extension period.

- 8.2.3.1 If such Successor Agreement has not been executed as of April 30, 2012, <u>AT&T-22STATE</u> shall convert this Agreement as of April 30, 2012 to <u>AT&T-22STATE</u>'s then current standard LWC Commercial Agreement and provide all services pursuant to the rates, terms and conditions of such standard LWC Commercial Agreement which shall include retroactive true-up of the standard LWC Commercial Agreement rates back to January 1, 2012 including proration of such rates on any LWC lines that were added, changed, or disconnected during this between January 1, 2012 and April 30, 2012.
- 3. LDMI Telecommunications, Inc. d/b/a Cavalier Business Communications, d/b/a Cavalier Telephone, d/b/a Cavalier Telephone and TV, d/b/a PAETEC Business Services in the state of Michigan; LDMI Telecommunications, Inc. d/b/a Cavalier Telephone d/b/a PAETEC Business Services d/b/a Cavalier Telephone and TV in the state of Ohio and LDMI Telecommunications, Inc. in the state of Wisconsin, (collectively referred to as "LDMI") are added as Parties to the Agreement.
- 4. For LDMI, the Agreement will be applicable in the states of Michigan, Ohio and Wisconsin.
- 5. McLeodUSA Telecommunications Services LLC in the states of Arkansas, Kansas, Texas and Wisconsin; McLeodUSA Telecommunications Services, L.L.C. d/b/a PAETEC Business Services in the state of Illinois; McLeodUSA Telecommunications Services, L.L.C. in the states of Indiana and Michigan; McLeodUSA Telecommunications Services, Inc. d/b/a PAETEC Business Services in the states of Missouri and Ohio; and McLeodUSA Telecommunications Services d/b/a PAETEC Business Services in the state of Oklahoma, (collectively referred to as "McLeodUSA") are added as Parties to the Agreement.
- 6. For McLeodUSA, the Agreement will be applicable in the states of Arkansas, Illinois, Indiana, Kansas, Michigan, Missouri, Ohio, Oklahoma, Texas and Wisconsin.
- 7. NETWORK TELEPHONE CORPORATION in the state of Alabama; Network Telephone Corporation d/b/a Cavalier Telephone d/b/a PAETEC Business Services in the state of Florida; Network Telephone Corporation d/b/a Cavalier Business Communications in the state of Georgia; Network Telephone Corporation d/b/a PAETEC Business Solutions in the states of Kentucky, Louisiana and Tenessee; and Network Telephone Corporation in the states of Mississippi and North Carolina; and Network Telephone Corporation d/b/a PAETEC Business Services in the state of South Carolina (collectively referred to as "Network Tel") are added as Parties to the Agreement.
- 8. For Network Tel, the Agreement will be applicable in the states of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina and Tennessee.
- 9. PAETEC Communications, Inc. in the states of California and Michigan and PaeTec Communications, Inc. in the states of Connecticut, Florida, Georgia, Illinois, North Carolina, Ohio and Texas, (collectively referred to as "PaeTec") are added as Parties to the Agreement.
- 10. For PaeTec, the Agreement will be applicable in the states of California, Connecticut, Florida, Georgia, Illinois, Michigan, North Carolina, Ohio and Texas.

- 11. Talk America, Inc, in the states of Alabama, Mississippi and Tennessee; Talk America, Inc, d/b/a Cavalier Telephone d/b/a PAETEC Business Services in the states of Florida and South Carolina: Talk America, Inc, d/b/a Cavalier Telephone in the states of Georgia and Louisiana; Talk America, Inc, d/b/a Cavalier Telephone d/b/a PAETEC Services in the state of Kentucky; Talk America, Inc, d/b/a Cavalier Telephone and TV d/b/a PAETEC Business Services in the state of North Carolina and Talk America, Inc, d/b/a Cavalier Telephone d/b/a PAETEC Business Services in the state of South Carolina, (collectively referred to as "Talk") are added as Parties to the Agreement.
- 12. For Talk, the Agreement will be applicable in the states of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississipppi, North Carolina, South Carolina and Tennessee.
- 13. The Other Phone Company, Inc. in the states of Alabama and Mississippi; The Other Phone Company, Inc. d/b/a Cavalier Telephone d/b/a PAETEC Business Services in the state of Florida; The Other Phone Company, Inc. d/b/a Access One Communications in the state of Kentucky; The Other Phone Company, Inc. d/b/a PAETEC Business Solutions in the state of Louisiana; The Other Phone Company, Inc. d/b/a PAETEC Business Services in the states of North Carolina and Tennessee; and The Other Phone Company, Inc. d/b/a Access One Communications in the state of South Carolina, (collectively referred to as "The Other Phone Company") are added as Parties to the Agreement.
- 14. For The Other Phone Company, the Agreement will be applicable in the states of Alabama, Florida, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina and Tennessee.
- 15. US LEC OF ALABAMA, LLC in the state of Alabama, US LEC of Georgia Inc. d/b/a PAETEC Business Services in the state of Georgia and US LEC of South Carolina, Inc. in the state of South Carolina, (collectively referred to as "US LEC") are added as Parties to the Agreement.
- 16. For US LEC, the Agreement will be applicable in the states of Alabama, Georgia and South Carolina.
- 17. Upon execution of this Amendment, the LWC Agreement between BellSouth Telecommunications, Inc. d/b/a AT&T Alabama, AT&T Florida, AT&T Georgia, AT&T Kentucky, AT&T Louisiana, AT&T Mississippi, AT&T North Carolina, AT&T South Carolina, and AT&T Tennessee, Illinois Bell Telephone Company d/b/a AT&T Illinois, Indiana Bell Telephone Company Incorporated d/b/a AT&T Indiana, Michigan Bell Telephone Company d/b/a AT&T Michigan, Nevada Bell Telephone Company d/b/a AT&T Nevada, The Ohio Bell Telephone Company d/b/a AT&T Ohio, Pacific Bell Telephone Company d/b/a AT&T California, The Southern New England Telephone Company d/b/a AT&T Connecticut, Southwestern Bell Telephone Company d/b/a AT&T Arkansas, AT&T Kansas, AT&T Missouri, AT&T Oklahoma, AT&T Texas and Wisconsin Bell, Inc. d/b/a AT&T Wisconsin (only to the extent that such AT&T Inc. owned ILEC provides Telephone Exchange Services as an ILEC in each of the states) and McLeodUSA Telecommunications Services, Inc. will be terminated.
- 18. Upon execution of this Amendment, the LWC Agreement between BellSouth Telecommunications, Inc. d/b/a AT&T Alabama, AT&T Florida, AT&T Georgia, AT&T Kentucky, AT&T Louisiana, AT&T Mississippi, AT&T North Carolina, AT&T South Carolina, and AT&T Tennessee, Illinois Bell Telephone Company d/b/a AT&T Illinois, Indiana Bell Telephone Company Incorporated d/b/a AT&T Indiana, Michigan Bell Telephone Company d/b/a AT&T Michigan, Nevada Bell Telephone Company d/b/a AT&T Nevada, The Ohio Bell Telephone Company d/b/a AT&T Ohio, Pacific Bell Telephone Company d/b/a AT&T California, The Southern New England Telephone Company d/b/a AT&T Connecticut, Southwestern Bell Telephone Company d/b/a AT&T Arkansas, AT&T Kansas, AT&T Missouri, AT&T

Oklahoma, AT&T Texas and Wisconsin Bell, Inc. d/b/a AT&T Wisconsin (only to the extent that such AT&T Inc. owned ILEC provides Telephone Exchange Services as an ILEC in each of the states) and Talk America, Inc. d/b/a Cavalier Telephone d/b/a Cavalier Business Communications and d/b/a Cavalier Telephone and TV, LDMI Telecommunications, Inc. d/b/a Cavalier Telephone d/b/a Cavalier Business Communications and d/b/a Cavalier Telephone and TV, Network Telephone Corporation d/b/a Cavalier Telephone and d/b/a Cavalier Business Communications, The Other Phone Company, Inc. d/b/a Access One Communications d/b/a Cavalier Telephone and d/b/a Cavalier Business Communications, (collectively referred to as "Talk America") will be terminated.

- 19. EXCEPT AS MODIFIED HEREIN, ALL OTHER TERMS AND CONDITIONS OF THE UNDERLYING AGREEMENT SHALL REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.
- 20. This Amendment shall become effective on January 1, 2012.
- 21. AT&T will file a copy of this fully executed amendment with the FCC under 47 U.S.C § 211.
