O R D E R

On December 5, 1991 South Anderson Water District ("South Anderson") filed an application with the Public Service Commission ("Commission") proposing to increase its fee for 5/8 x 3/4 Inch Meter Service Connections from \$400 to \$500 and to increase the rate for its Bulk Water Station by \$.29 per 1,000 gallons from \$2.74 per 1,000 gallons to \$3.03 per 1,000 gallons due to a recent 29 cent purchased water adjustment.

On January 3, 1992, the Commission sent South Anderson a letter requesting that certain filing deficiencies be cured by January 18, 1992. The requested information curing the deficiencies was filed with the Commission on January 23, 1992. The affidavit of public notice was filed on February 6, 1992.

A rate for South Anderson's Bulk Water Station was not previously set forth in its tariff. However, information on file with the Commission indicates that the proposed rate is reasonable and will cover South Anderson's costs for providing the water. South Anderson provided cost justification for its 5/8 x 3/4 Inch Meter Service Connection fee which indicates that the proposed

rate will cover the incremental costs of providing the service with a reasonable contribution to overhead.

The Commission, having considered the evidence of record and being sufficiently advised, finds that the charges proposed by South Anderson are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The charges in Appendix A, which is attached hereto and incorporated herein, are approved for services rendered by South Anderson on and after the date of this Order.


2. Within 30 days of the date of this Order, South Anderson shall file its revised tariff sheets setting forth the charges approved herein.

The following rates and charges are prescribed for the customers in the area served by South Anderson Water District. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

Bulk Water Station

Flat Rate \$3.03 per 1,000 gallons

Service Connection Fee

5/8 x 3/4 Inch Meters \$500
