O R D E R

On April 17, 2006, Southeast Daviess County Water District (“Southeast Daviess”) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Southeast Daviess purchases water from the Owensboro Municipal Utilities (“Owensboro”).
2. Owensboro notified Southeast Daviess that, effective June 1, 2006, Owensboro’s wholesale water rate to Southeast Daviess would increase from \$1.360 per 1,000 gallons to \$1.491 per 1,000 gallons.
3. During the 12 months ending March 31, 2006, West Shelby purchased 579,585,200 gallons of water from Owensboro and sold 546,137,670 gallons. The increase in the cost of purchased water is \$75,926, resulting in a purchased water adjustment of \$0.14 per 1,000 gallons.
4. The purchased water adjustment of \$0.14 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment of \$0.14 per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after June 1, 2006.
2. The proposed tariff sheets filed by Southeast Daviess County Water District are approved as filed.
