ORDER

On April 3, 2012, Tom Vierheller, Beverly May, and the Sierra Club (collectively, "Movants") filed a motion requesting an extension of time to file responses to Commission Staff's First Request for Information and Objections and Responses to Kentucky Power Company's ("Kentucky Power") First Request for Information. Movants note that, pursuant to the Commission's current procedural schedule, their responses to discovery propounded by Commission Staff and Kentucky Power were due on or before April 2, 2012. In support of their request, Movants state that, due to their local counsel being out of town, they retained a local copy service to facilitate the filing of the responses. Although Movants mailed a compact disc containing all of the attachments to their discovery responses and emailed their discovery responses to the parties, including Commission Staff, on April 2, 2012, Movants informed Commission Staff that the copy service was unable to print all the requisite copies and deliver them to the

Commission by the April 2, 2012 deadline. Accordingly, Movants request a one-time extension of time to file the subject discovery responses by Tuesday, April 3, 2012.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that Movants have established good cause to grant them a one-day extension of time as requested.

IT IS THEREFORE ORDERED that Movants' motion for a one-day extension of time is granted and their responses to the information requests of Commission Staff and responses and objections to Kentucky Power are accepted for filing on April 3, 2012.
