

On February 17, 2012, Sierra Club filed a motion to compel disclosure. On February 22, 2012, Kentucky Power Company filed its response to the Sierra Club's motion to compel.

On February 24, 2012, Sierra Club filed a motion for an extension of time to file direct testimony, and on February 29, 2012, Kentucky Power Company filed its response to that motion. The February 24 motion and the February 29 response discussed the various communications between Sierra Club and Kentucky Power with regards to data sought to be compelled. Kentucky Power then filed a supplemental data response, and the Sierra Club filed its direct testimony on March 12, 2012.
