ORDER

On February 17, 2012, Tom Vierheller, Beverly May, and Sierra Club (collectively "Sierra Club") filed a motion requesting the Commission to compel Kentucky Power Company ("Kentucky Power") to disclose certain documents in response to Sierra Club's initial data requests. In its motion, Sierra Club states that on January 27, 2012, Kentucky Power served responses to Sierra Club's initial data requests. The motion further states that Sierra Club requested, but was not provided, information regarding key assumptions and analyses used by Kentucky Power to support its application, such as Strategist input and output files for each alternative option evaluated, Aurora modeling files, and certain information related to Kentucky Power's parent company, American Electric Power.

On February 22, 2012, Kentucky Power filed its response in opposition to the Sierra Club's motion to compel, requesting that the motion be denied. Kentucky Power

states that its personnel have worked with the Sierra Club and Ventyx, the licensor of the Strategist model, to assist Sierra Club in obtaining access to protected files. Kentucky Power states that it has worked diligently to respond to Sierra Club's data requests, that "much, if not all, of the information . . . was in fact produced, or is now available," that Kentucky Power is producing additional information in a live format, and that it is willing to make available a knowledgeable representative for the limited purposes of assisting Sierra Club in initially executing Strategist.

On February 24, 2012, Sierra Club filed a motion for an extension of time to file direct testimony, and in that motion it outlined various communications with Kentucky Power concerning the requested information. On February 29, 2012, Kentucky Power filed its response to that motion and included a discussion of the additional information that had been provided to Sierra Club.

Based on the evidence in the record and being otherwise sufficiently advised, the Commission finds that the information that has now been provided by Kentucky Power to Sierra Club is responsive to its initial data request and the motion to compel should be denied as moot.

IT IS THEREFORE ORDERED that the Sierra Club's motion to compel is denied. as moot.
