



The Kentucky State men's basketball team lost an exhibition game to Western Kentucky University 80-58 Tuesday night in Bowling Green.

KSU was led by Tony Johnson with 20 points and 10 rebounds. Larry Williams chipped in 15 points and had five rebounds, and Kenny Jones had a double-double with 10 points and 10 rebounds.

KSU at one point led by nine points, but the Thorobreds were hurt by their 29 turnovers and 13 percent shooting from 3-point range.

Daniel Emerson led WKU with 15 points and was one of four Hilltoppers in double figures.

KSU opens its regular season Nov. 18, at Claflin University in Orangeburg, S.C. The Thorobreds will be hosting an alumni game this Saturday at the Exum Center at 6 p.m.
