

NOTICE: Wholesale Rate Increase

Dear Wholesale Customer:

The City of Tompkinsville has filed a proposed rate schedule which will increase by ten percent (10%) the rate which it currently charges to Monroe County Water District for water service. Tompkinsville currently charges Monroe County Water District \$1.39 for water service. It proposes to charge Monroe County Water District \$1.53 for water service effective January 1, 2011.

The rate contained in this notice is the rate proposed by the City of Tompkinsville. The Public Service Commission, however, may order this rate to be charged differently from the proposed rate contained in this notice.

Any corporation, association, or person with a substantial interest in the matter may, by written request, within thirty (30) days after mailing of this notice of the proposed rate changes request to intervene. Intervention may be granted beyond the (30) day period for good cause shown.

Any person who has been granted intervention by the Public Service Commission may obtain copies of the rate application and any other filings made by the City of Tompkinsville by contacting Debra Hale by mail at 206 N. Magnolia Street, Tompkinsville, Kentucky 42167 or by phone (270)487-6776.





Due to a rate increase from the City of Tompkinsville, notice is hereby given that Monroe County Water District has filed An Application for a Purchased Water Adjustment with the Kentucky Public Service Commission for the purpose of adjusting its water rates. Customer rates will increase by 18 cents per 1,000 gallons used. The proposed change will be effective for all usage on and after January 1, 2011.
