
**Motion To Submit Application For Decision On The Record**

Kentucky Power Company moves the Public Service Commission of Kentucky to submit the Company's application for a certificate of public convenience and necessity authorizing the conversion of Big Sandy Unit 1 to a natural gas fired unit for a decision on the existing record in this case. If the Commission grants this motion, the Company waives its right to a hearing.

Alternatively, if the Commission believes a hearing is required to resolve any factual issues, or that a hearing would be in the public interest, the Company requests that the hearing be advanced on the Commission's calendar from the currently scheduled June 4, 2014 hearing date to the earliest convenient date for the Commission. Advancing the hearing date, and hence an order on the application, will assist the Company in bringing the converted Big Sandy Unit 1 on line at the earliest practicable date. Because no testimony was filed by Kentucky Industrial Utility Customers, Inc. the remaining steps under the current procedural schedule are moot.


