NOTICE TO THE CUSTOMERS OF MAGOFFIN COUNTY WATER DISTRICT

On April 8, 2015, Magoffin County Water District ("Magoffin District") applied to the Kentucky Public Service Commission ("PSC") for authority to adjust its rates for water service. The initial proposed effective date of the requested rate adjustment was made pursuant to the date of an Order granting an increase by the PSC. After performing a review of Magoffin District's application and records, the PSC Staff has recommended to the PSC that Magoffin District adjust its rates to their retail customers that are different from those proposed by Magoffin District. The tables below reflect the present retail rates and the retail rates proposed by the PSC Staff:

The monthly water bill for the average retail customer using 5,000 gallons of water monthly will increase from \$34.85 to \$39.90, or 14.5 percent.

Any person may submit comments on the proposed rates. Comments shall be in writing and shall be submitted to the Executive Director, Public Service Commission, 211 Sower Boulevard, P.O. Box 615, Frankfort, Kentucky 40602. Comments may also be submitted by electronic mail to [psc.info@ky.gov](mailto:psc.info@ky.gov). If the Commission does not receive any objections or requests for intervention establishing the grounds for the request including the status and interest of the party or requests for hearing in this matter within thirty (30) days of initial publication or mailing of the notice, the commission may take final action on the application and shall proceed to render a decision in the matter.
