**ATTORNEY GENERAL’S MOTION TO INTERVENE
AND OBJECTION TO BUSH GARDENS ENTERPRISES, LLC’S REQUEST FOR
EXPEDITED REVIEW**


Comes now the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, and pursuant to KRS 367.150(8), which grants him the right and obligation to appear before regulatory bodies of the Commonwealth of Kentucky to represent consumers’ interests, hereby moves the Public Service Commission to grant him status as an intervenor party in this action pursuant to 807 KAR 5:001 Section 4(11).

Furthermore, the Attorney General objects to Bush Gardens Enterprises, LLC’s (“BGE”) request for deviation from 807 KAR 5:076. BGE has requested an expedited review of only thirty days to evaluate its pending application, instead of the six month period set forth in 807 KAR 5:076(7). Due to the fact that BGE is proposing an extraordinarily high monthly residential sewer rate of \$194.61 to be placed upon its customers, the Attorney General respectfully requests the full six month review period in order to fully develop the record, allow for public comment, and investigate whether there are lesser cost alternatives.

Wherefore, the Attorney General requests status as an intervenor party in the present action. The Attorney General further requests that the Commission DENY BGE’s request for deviation from 807 KAR 5:076 and expedited review of its pending application.


