O R D E R

On April 12, 1988, Sandy Valley Water District ("Sandy Valley") filed its application seeking to increase its rates for water service. Sandy Valley asked for an increase in revenue of \$68,599.

Neither Sandy Valley nor the Commission sought a hearing in this matter. There were no intervenors and all requested information has been filed.

On May 12, and May 13, 1988 the Commission Staff conducted a field review to determine the correctness of test period data and to evaluate pro forma adjustments proposed in Sandy Valley's filing. The Staff issued its report and recommendations on June 10, 1988. On July 15, 1988, Sandy Valley filed its response to the Staff Report stating that it accepted the Staff's finding and recommendations. After careful review and investigation the Commission affirms the Staff's recommendations and grants an increase in revenues of \$75,867 annually.

FINDINGS AND ORDERS

1. The rates and charges in Appendix A are fair, just, and reasonable rates and charges to be charged by Sandy Valley in that they should produce additional annual revenues of \$75,867.

2. Within 30 days of the date of this Order, Sandy Valley should file with this Commission its revised tariff sheets setting out the rates approved herein.


IT IS THEREFORE ORDERED that:

1. The rates and charges in Appendix A are the fair, just and reasonable rates and charges to be charged by Sandy Valley for service rendered on and after the date of this Order.

2. Within 30 days of the date of this Order, Sandy Valley shall file with this Commission its revised tariff sheets setting out the rates approved herein.
